ONE YEAR LIMITED WARRANTY: The structure of a Thuro-Bilt Inc. trailer is warranted to the original retail purchaser against defects in material or workmanship for a period of one year. This warranty is extended to the original purchaser only and is terminated upon sale, assignment, or other transfer of the trailer by the original purchaser. The trailer will be repaired or replaced at no charge if such defect is not caused by abuse or misuse of the trailer loading more than gross vehicle weight stated on certification label, negligence, accident, alterations, commercial applications, or repair by a person not authorized by Thuro-Bilt Inc. will invalidate warranty. It is Thuro-Bilt Inc's policy to service and assist its customers under any and all circumstances.

SERVICE: It is the purchaser's responsibility to maintain and service the trailer. The trailer must be regularly serviced and documented. **FAILURE TO PROPERLY MAINTAIN AND SERVICE YOUR TRAILER VOIDS ALL WARRANTIES SAID AND IMPLIED.**

LIMITATIONS: The sole responsibility of Thuro-Bilt Inc. under the warranty shall be to repair and replace parts at the Thuro-Bilt Inc. factory or at a place approved in writing by Thuro-Bilt Inc. Thuro-Bilt Inc. reserves the right to decide if the material defect or workmanship should be serviced at the factory. Thuro-Bilt Inc. shall **NOT** be held liable for any cost for transportation of the trailer to and from the place of repair. Any parts returned for warranty must be returned pre-paid freight to Thuro-Bilt Inc. This warranty specifically **EXCLUDES** tires, wheels, lights, axles, brakes, brake components, trailer hitch, hitch components, jacks and casters, suspension components, latches, windows, 0feed door assembly, camper door assembly and paint and will be covered **ONLY** by the original manufacturer's warranty.

DISCLAIMER OF CONSEQUENTIAL AND INCIDENTAL DAMAGES:

ALL OTHER OBLIGATIONS OR LIABILITIES, INCLUDING INCIDENTAL OR CONSEQUENTIAL DAMAGES OR CONTINGENT LIABILITIES ARISING OUT OF THE FAILURE OF ANY PARTS TO OPERATE PROPERLY, ARE HEREBY EXCLUDED, INCLUDING ANY DAMAGES RESULTING FROM LOSS OF USE, INCONVENIENCE, LOSS OF TIME, COMMERCIAL LOSS, OR ANY OTHER TYPE OF DAMAGES, GENERAL OR SPECIFIC, FORESEEN OR UNFORESEEN.

LIMITATION AND DISCLAIMER OF IMPLIED WARRANTIES:

WARRANTOR EXPRESSLY DENIES ANY CLAIM TO MERCHANTABILITY, IMPLIED WARRANTIES OR FITNESS FOR A PARTICULAR PURPOSE AND ANY OTHER IMPLIED WARRANTIES. There is no warranty made by Warrantor beyond that contained in this Warranty. No person has authority to enlarge, amend or modify this Warranty.

PRIOR WRITTEN CONSENT: Thuro-Bilt Inc. will not make reimbursements for any repairs and/or adjustments without written consent. Any Thuro-Bilt Inc. trailer found to have defective material or workmanship must be serviced or corrected by the Thuro-Bilt Inc. factory. Bilt Inc. with respect to each specific repair and/or adjustment and cost of repair or adjustment must be agreed on by Thuro-Bilt Inc. Cost of repair will not exceed the price charged by Thuro-Bilt Inc. for cost of repair or parts.

REQUIRED PROCEDURES:

To increase the response time of the correction of any problem covered by this warranty, the following procedures must be followed:

1. To validate the Warranty, the original purchaser must sign and return the Warranty Registration Card to Thuro-Bilt Inc. within (10) days of the date of purchase.
2. Within (5) days after discovering a problem, return your trailer to your Thuro-Bilt Inc. dealer for inspection. Dealers are responsible for fixing minor problems without charge to you or to the factory.
3. If your local dealer cannot repair the problem, and you wish to make a claim under this warranty, bring your trailer to the Thuro-Bilt Inc. factory for inspection. If you cannot come to the factory, you must notify Thuro-Bilt Inc. 885 Flournoy Valley Rd, Roseburg, OR 97471, by registered letter within (10) days after discovering the defect. Include your name, address, home and work phone number, a complete description of the problem, the VIN # of your trailer, the name of the dealer from whom you purchased your trailer, and photographs which clearly show the defect.
